

**Shop your way to \$10K**  
*Competition Terms and Conditions*

1. The promotion is organised by Erceg Management, of 320 Lord Street, Perth WA 6000
2. Information on how to take part and prize allocation form part of these terms and conditions.
3. The Shop your way to \$10K (cash) competition commences at 9.00am WST on Friday 1<sup>st</sup> November 2024 and concludes at 5pm on Sunday 15<sup>th</sup> December 2024.
4. Participation is open to individuals over the age of 18.
5. The winner will be notified via the phone or email address provided, at the conclusion of campaign date.
6. Prior to entering the competition, it is assumed that all entrants have read and understood these terms and conditions.
7. Entrants must make a purchase at any retail store to the value of \$25 (or more) within Alexander Heights Shopping Centre, Dunsborough Marketplace, Lakes Shopping Centre, Parks Shopping Centre, Power Shopping Centre, Springs Shopping Centre, or 2<sup>nd</sup> Avenue Plaza, scan the QR code or visit the centre website, and complete all competition fields to enter. The receipt of purchase is to be uploaded via the QR code or centre website, with all fields to be completed. The spend must be made in store. Receipts can be accumulated to reach the \$25 spend requirement.
